## ENTRY REQUIREMENTS

i. Bachelor of Pharmacy (Level 6, Malaysian Qualifications Framework (MQF) or equivalent in a related field with a minimum CGPA of 2.75 or its equivalent as accepted by the Senate of Lincoln University College; or

ii. Bachelor of Pharmacy (Level 6, MQF) or equivalent in a related field with a minimum CGPA of 2.50 and not achieving a CGPA of 2.75, may be admitted subject to rigorous internal assessment; or

iii. Bachelor of Pharmacy (Level 6, MQF) or equivalent in a related field but did not achieve a CGPA of 2.50, may be admitted subject to a minimum of 5 years of working experience in the relevant field.

International students must have proof of good proficiency in verbal and written English. For example, International English Language Testing System (IELTS) score of 5.0 or its equivalent. If a student does not meet this requirement, HEPs must offer English proficiency courses to ensure that the student's proficiency is sufficient to meet the needs of the programme.
